

ORDINANCE NO. _____

**AN ORDINANCE AUTHORIZING
THE CITY OF O’FALLON TO
PURCHASE REAL ESTATE
CONSISTING OF 50 ACRES
SITUATED BETWEEN PORTER
ROAD AND VENITA DRIVE**

WHEREAS, the Corporate Authorities of the City of O’Fallon deem it advisable, necessary and in the public interest for the City of O’Fallon to acquire a parcel of real estate situated between Porter Road and Venita Drive, O’Fallon, Illinois consisting of fifty (50) acres; and

WHEREAS, the real estate is needed for public purposes including for a City park; and

WHEREAS, pursuant to the provisions of 65 ILCS 5/11-61-3 the municipality is authorized to purchase real property for public purposes; and

WHEREAS, James C. Obernuefemann, Dianne M. Obernuefemann, Lucille Kombrink, Raymond Obernuefemann and Angeline Obernuefemann have agreed to sell such property to the City of O’Fallon according to the terms of the proposed contracts previously submitted to the City of O’Fallon.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF O’FALLON, ST. CLAIR COUNTY, ILLINOIS;

Section 1.

The City Council hereby determines that it is advisable and necessary and in the interest of public that the City of O’Fallon purchase from the Sellers, James C. Obernuefemann, Dianne M. Obernuefemann, Lucille Kombrink, Raymond Obernuefemann and Angeline Obernuefemann, consisting of fifty (50) acres situated between Porter Road and Venita Drive, O’Fallon, Illinois, according to the terms as contained in the proposed contract of James C. Obernuefemann, Dianne

M. Obernuefemann, Lucille Kombrink, Raymond Obernuefemann and Angeline Obernuefemann.

Section 2.

The Mayor and Clerk of the City are hereby authorized and directed to execute the documents necessary and do all things essential to complete the purchase the aforementioned real estate from James C. Obernuefemann, Dianne M. Obernuefemann, Lucille Kombrink, Raymond Obernuefemann and Angeline Obernuefemann.

Section 3.

This ordinance shall be in full force and effect from and after its passage and approval and its publication in the manner provided by law.
