**AN ORDINANCE RESCINDING  
THE CODE OF ORDINANCES  
OF THE CITY OF O'FALLON,  
ILLINOIS, CHAPTER 98, SECTION  
98.08 VEHICLES ON SIDEWALKS**

**WHEREAS**, Ordinance 98.08, **VEHICLES ON SIDEWALKS**, prohibits the operation of vehicles, including bicycles on the sidewalk, and;

**WHEREAS**, Many cyclists, including children, ride their bicycles on the sidewalk in an effort to avoid vehicular traffic, and;

**WHEREAS**, The Illinois Vehicle Code, 625 ILCS 5/11-1512, allows bicycles on the sidewalk under certain conditions that give right-of-way to pedestrians, and;

**WHEREAS**, The City of O'Fallon Code of Ordinances Chapter 70 Section 70.02 adopts the Illinois Vehicle Code in its entirety, and;

**WHEREAS**, The Illinois Vehicle Code and other sections of the Code of Ordinances prohibit the operation of other vehicles on the sidewalk, and;

**WHEREAS**, The City determines that it is in the best interest of cyclists to be able to ride on the sidewalk under certain conditions as outlined by the Illinois Vehicle Code, and;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF O'FALLON, ST. CLAIR COUNTY, ILLINOIS AS FOLLOWS:

**CHAPTER 98 "STREETS AND SIDEWALKS", SECTION 98.08 "VEHICLES ON SIDEWALKS"** be rescinded.

Upon its passage and approval, this Ordinance shall be in full force and effect ten (10) days after its publication in pamphlet form as required by law.
