**AN ORDINANCE DECLARING THE  
FOLLOWING VEHICLES AND  
EQUIPMENT AS SURPLUS  
PROPERTY AND FOR SALE  
PURSUANT TO 65 ILCS 5/11-76-4**

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF  
THE CITY OF O'FALLON, ST. CLAIR COUNTY, ILLINOIS AS FOLLOWS:**

**SECTION 1. DISPOSAL.** It is the best interest of the City to dispose of the vehicles as heretofore mentioned, as the City no longer has a need for same.

**SECTION 2. METHOD.** (1) Said vehicles may be disposed of by sale with or without advertising for sale, or (2) may be converted into some other form that is useful to the City by using said material within, or (3) may be conveyed or turned in as part payment on a new purchase of any similar article. However, such vehicle shall not be turned in as part of a purchase price except upon receipt of competitive bids, in such manner as may be further

prescribed by an amendment to this ordinance, after notice to all bidders that a vehicle will be turned over as part of the purchase price.

Upon its passage and approval, this Ordinance shall be in full force and effect ten (10) days after its publication in pamphlet form as required by law.
