**AN ORDINANCE AMENDING
ORDINANCE 3621 BUDGETING
FOR ALL CORPORATE PURPOSES

Section 2. That Fund 47- Library Bond Construction be added to read as indicated on attached revised page 27 of this amended ordinance and new totals inserted thereof.

Section 3. That Fund 69- Family Sport Park in Ordinance 3621, be amended to read as indicated on attached revised page 31 of this amended ordinance and new totals inserted thereof.
