For Commercial Projects

The following must be documented in the code data block located on the front page of the construction documents. The Illinois licensed designer must include his or her raised seal on all construction documents.

The sealed COMcheck report must be submitted as a separate full-size sheet with the construction documents and as two (2) 8 ½ x 11 copies.

- Three (3) complete sets of architect / engineer sealed building plans (each page sealed, please)
- Four (4) full-size sets of sealed civil plans (each page sealed, please)
- One (1) full size and one (1) 11" x 17" sealed site plan
- Fire Sprinkler Application, Four (4) full-size sealed Fire Sprinkler Plans, calculations and cut sheets
- Fire Alarm Application, Four (4) full-size sealed Fire Alarm Plans and cut sheets
- Completed Data Sheet for Proposed Fire Service Installation Including Fire Pump and Related Facilities, and Application for Special Connection
- Completed "Final Site Plan Check Sheet"
- Engineering Plan Review Fee Payment Responsibility Form **with** check payable to "The Fulton Group"
- One (1) photometric plan for exterior site lighting
- One (1) Landscape Plan
- Required Parking Schedule
- Separate sign permit application (if applicable)
- Two (2) B & F Technical Code Services, Inc. Plan Review Submittal Building Plan Review Checklist and Payment Responsibility form
- Two (2) construction manuals
- Two (2) geotechnical reports
