Roadways PARTIALLY maintained/owned by the City:

Bethel Rd. – From N. Lincoln west approximately .2 miles (remainder O'Fallon Twp./ Caseyville Twp.)

Borchers Ln – From Scott-Troy Rd. east approximately .27 miles (1400 feet). (remainder O'Fallon Twp.)

Bowler Rd. – From N. Lincoln/O'Fallon-Troy north approximately .3 miles (1550 feet). (remainder O'Fallon Twp.)

N. Green Mount Rd. – (Schwaegel Rd.) From Regency Park/Pierce north to W. State St.

Hartman Ln. – From W. Hwy 50 south to Meadowbrook (remainder St. Clair Co. Hwy Dept.)

W. Hwy 50 – From Hartman Ln. to Old Collinsville Rd.

Lincoln – From Hwy 50 north to Jennifer Ct. (remainder St. Clair Co. Hwy Dept.)

Milburn School Rd. – From Simmons Rd. west to approximately 415 feet west of Pausch Rd.

From Merriam Parkway west approximately .46 miles (2400 feet).

From Old Collinsville Rd. east approximately .51 miles

** Portions of Milburn School Rd. Not included above are the jurisdiction of Caseyville Twp.

Old Collinsville Rd. – From W. Hwy 50 to Frontage Rd. Northbound lane ONLY. (southbound lane Fairview Heights, south of Hwy 50 – Fairview Heights) (From Frontage Rd. north approximately .6 miles/approximately 150 feet north of Rowe Ln. – Fairview Heights)

From approximately 150 feet north of Rowe Ln. north to approximately .5 miles north of Milburn School Rd. (remainder Caseyville Twp.)

Pausch Rd. – From Milburn School Rd. north approximately .3 miles (remainder Caseyville Twp.)

N. Seven Hills Rd – From approximately .13 miles (660 feet) north of E. State St. north to approximately .16 miles (865 feet) north of Moye School Rd. (remainder O’Fallon Twp.)

Shiloh Valley Twp. Line Rd. - From approximately .24 miles (1300 feet) south of US Hwy 50 south/east to approximately 1.01 miles west of S. Rieder Rd. (remainder O’Fallon Twp.)

Simmons Rd. – From approximately .1 mile north of Porter Rd. north to approximately 130 feet north of Lakeview Ln.

From approximately .15miles (765 feet) south of Milburn School Rd./Fairwood Hills north to Kyle Rd.

** Portions of Simmons Rd. not listed above are the jurisdiction of Caseyville Twp.

W. State St. – From Lincoln Ave. west to approximately 300 feet west of Oberneufemann Rd./N. Green Mount Rd. (remainder IDOT).

Weil Rd. – From approximately .44 miles (2300 feet) north of O’Fallon-Troy Rd. north to approximately .11 miles (600 feet) north of Torchlight Ln. (Remainder O’Fallon Twp.)
