a. Bank Clock Restoration

Updated contributions total; we met and exceeded the goal of \$24,000. The City of O'Fallon has designated the O'Fallon Historical Society to enter into contract with the restoration company. Multiple issues still need to be agreed upon, such as liability for future repairs, insurance, etc. The Historical Society has formed a special committee to address all issues that will involve this restoration, future maintenance, and method of payment. The yellow, plastic wrapping used as publicity has recently become very ragged. Commission decided to hire DeMond Signs to remove it and use money from the fundraiser to pay for it. Brian Keller raised the issue of sending letters to donors for their individual tax returns; Brian will create and send these necessary letters to donors. An all-inclusive list of donors will be compiled for next meeting to ensure all donors will be recognized.

- b. St. Clare School plaque presentation is planned for 9:00 a.m., Jan. 23, 2014 in the school gymnasium in conjunction with an all-school assembly (after 8:30 mass ends). A Commission member will read an abbreviated description of the building and its history and possibly answer questions from the student body.
