4. Discussion

a. Bank Clock Restoration

Progress of work was checked recently with Miller & Maack, and a report of findings and associated costs was presented (dated May 6, 2014). New electronic chimes can add as much as \$6,200 to the original estimate. Commission members discussed the impact and generally agree that this new assessment of the cost of chimes may be too extravagant and expensive for this project. It has also been reported that the city is concerned with the future cost of maintenance and software for the chimes. Spengler will research other chimes options.

The approximate contribution total is \$34,000. Sabella will draft a program to be used at the rededication ceremony that will include donors, amount contributed, and their desired hour. Other preparations for the ceremony include invitations for all donors, newspaper/press releases, plaque, logistics of blocking street(s) for ceremony, possible live music, and food truck(s).

Jordan suggested an additional outdoor event at the clock to resemble New Year's Eve in Times Square (N.Y.). All in attendance generally agreed that this could be a fun, worthwhile event.

b. Wachter Building

Brown presented an architectural description which was read and edited. Commission proposed target date of October 2014 to designate the building as a landmark.

- **c.** No progress has been made gaining information on the trolley charging station near Hartman Lane.
- **d.** Randall presented an example of the award that the Belleville Historic Preservation Comm. uses. This commission can possibly use or adapt this for future use in O'Fallon.
- **e.** Postcards will be created for recent landmarks St. Clare School and OTHS Gymnasium. Additionally, awarding of the plaque to OTHS Gymnasium needs to be finalized.

5. Work Session:

- **a.** Randall presented commission members with a request by a communications company planning to install a cell phone tower near O'Fallon (Lincoln and Kyle). The location is not within city limits. Company wanted potential impacts of the tower from an historic preservation perspective.

 - 2. The first-built sub-division home in the Smiley neighborhood 101 Dartmouth Ave.
