3. Public Hearings: none
4. Discussion:
 - a. Visitors: Three board members from the Mother Jones Museum, Mt. Olive, Ill. They retold stories of growing up in an area where most residents were miners.
 - i. biggest unionized group was in Southern Illinois
 - ii. 1898 strike in Virden, 4 of 7 killed were from Mt. Olive
 - iii. miners started own cemetery when they were barred from using city cemetery
 - iv. Mother Jones wanted to be buried there with her comrades
 - v. railroads owned many of the mines to supply their own trains
 - vi. coal companies often pitted different nationalities against each other
 - b. City is in negotiations with interested party to purchase Old City Hall. Announcement may be made at May 2, 2016 council meeting.
 - c. FYI: Harter's former bowling alley facility on West State St. has potential purchaser.
 - d. Possible future designations
 - i. St. Ellen Mine/Park – continue working on each part. Planned work session next meeting to scan funeral records in order to learn statistics of miners, i.e., country of origin, age, cause of death, etc.
