WHEREAS, the City of O'Fallon, a municipal corporation, has entered into an agreement with Byrne & Jones Construction for O'Fallon Parks Infield Turf Improvements in the amount not to exceed \$2,489,000.00, and

That the City of O'Fallon authorizes its appropriate representatives to enter into an agreement with Byrne & Jones Construction in the amount not to exceed \$2,489,000.00. Total of contract \$2,416,000.00 plus a 3% contingency of \$73,000.00 and any necessary budget adjustment be made for the FY22 budget.
