Background: While there are revenues to offset the expenditures, our auditors have advised that recent government accounting procedures require a budget amendment or else a notation will be cited in the audit report. In reviewing our year-end Budget Performance Report, there were a few funds that exceeded the budgeted expense. Due to the increase in TIF increment for Central Park TIF, the distribution to the developer was higher than budgeted. There was also additional purchases from the Restricted Police Trust account. Social Security wages were also underestimated and finally, the service charges for the Harley Davidson Debt Service bond was higher. Staff Is requesting amendments be made to the FY 22 budget.

necessary transfers and budget amendments for the following funds: Central

Park TIF, Social Security, Police Trust Fund and Harley Davidson Debt

Service, or any other fund that may need to be adjusted.
