## O'FALLON CITY COUNCIL MINUTES OF THE REGULAR COUNCIL MEETING Draft October 6, 2014

The regular meeting was called to order at 7:00 p.m. by City Clerk Goodwin who led the Council in "The Pledge of Allegiance to the Flag."

Philip Goodwin, City Clerk, called the roll: Gene McCoskey, present; Richie Meile, present; Ed True, present; Jerry Albrecht, present; Jerry Mouser, present; Kevin Hagarty, present; John Drolet, present; Herb Roach, present; Michael Bennett, present; Courtney Cardona, present; Jim Hursey, present; Ray Holden, present; David Cozad, present; Harlan Gerrish, present. A quorum was declared present.

City Clerk Goodwin asked for a motion to appoint a Mayor Pro Tem. Motion by J. Albrecht and seconded by H. Roach to appoint Alderman Mouser as Mayor Pro Tem. All ayes. Motion carried.

**Background:** The AFSCME contract covering all EMS employees expired on April 30, 2014 and negotiations have been ongoing since that date. The City was notified on October 15, 2014 that the Local had approved the three year contract. Contract highlights include:

#### 1. Article 12 Clothing Allowance, Section 3

Increase in clothing allowance of \$150.00 for an annual total of \$800.00

#### 2. Article 13 Wage Rates

Base pay rates for each classification covered by this Agreement shall be increased as follows:

Effective May 1, 2014 increased by 3.00%.

Effective May 1, 2015 increased by 3.00%.

Effective May 1, 2016 increased by 3.00%.

Staff who successfully transition from EMT-Basic to EMT-Paramedic will see an increase in his/her salary consistent with the difference between the starting wages between the two classifications.

#### 3. Article 16 Work Schedule

Work schedules will be posted three (3) months in advance. This is the schedule for the next year beginning January 1. Schedules can be posted with less than three (3) months' notice if it's mutually agreed upon by the bargaining unit and the administration. (Current agreement requires 6 months' notice)

An employee who is called in to work during scheduled time off shall have the option:

To work, and have compensatory time paid in lieu of overtime payments. If the employee elects compensatory time in lieu of cash payment, the employee shall not be allowed to carry over thirty six (36) hours. Compensatory time shall be earned at time and one-half

AN ORDINANCE DESIGNATING AS A LOCAL HISTORIC LANDMARK THE WACHTER BUILDING AT 226 WEST STATE STREET IN O'FALLON, ILLINOIS, PURSUANT TO THE REQUIREMENTS OF CHAPTER 151 OF THE O'FALLON CODE OF ORDINANCES (Situated in Parcel Number 04-30.0-224-010)

**WHEREAS,** Chapter 151 of the City of O'Fallon Code of Ordinances provides rules and parameters for designating historic structures and districts; and

**WHEREAS,** Chapter 151 gives the Commission responsibility for recommending to the City Council those structures or districts that have significant local, state or national historical or architectural importance; and

**WHEREAS,** the Commission has received and accepted an application from Sal Cincotta for designation as a local historic landmark; and

**WHEREAS**, the Commission held a public hearing pursuant to the requirements of Chapter 151 on October 7, 2014 to consider the designation of the Wachter Building at 226 West State Street as a local historic landmark; and

**WHEREAS**, the Commission unanimously recommends to the City Council that the Wachter Building at 226 West State Street in the City of O'Fallon represents a site that is significant to the historical, cultural, artistic, social, ethnic, or political heritage of the community; embodies elements of design, detailing, materials or craftsmanship that render it architecturally significant; and represents a sense of time and place unique to the City.

## NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF O'FALLON, ST. CLAIR COUNTY, ILLINOIS AS FOLLOWS:

Section 1. Findings. Based upon the City Council's review of the application and the testimony giving at the public hearing, and having made itself familiar with the project, the council makes the following affirmative determinations: the Wachter Building at 226 West State Street is significant to the historical, cultural, artistic, social, ethnic, or political heritage of the community; embodies elements of design, detailing, materials or craftsmanship that render it architecturally significant; and represents a sense of time and place unique to the City.

<u>Section 2. Adoption.</u> That the Wachter Building at 226 West State Street shall hereafter be designated as a landmark of local historical significance pursuant to the provision of Chapter 151.

<u>Section 3. Filing.</u> That the City Clerk be and is hereby directed to file with the Recorder of deeds of St. Clair County, Illinois a copy of this ordinance.

<u>Section 4, Passage.</u> Upon its passage and approval, this ordinance shall be in full force and effect ten (10) days after its publication in pamphlet form as required by law.

The following criteria as set forth in Section 151.31 of Ordinance 3043 of the City of O'Fallon will be considered in designating an area, place, building, structure or other object as an O'Fallon Landmark:

- 1. Its significance or value as part of the historical, cultural, artistic, social, ethnic, political, or other heritage of the community, state or nation;
  - 2. Its location as a site of a significant local, county, state or national event;
  - 3. Its identification with a person who significantly contributed to the development of the community, county, state or nation;
  - 4. Its identification as the work of a master builder, designer or architect whose individual work has influenced the development of the community;
- 5. Its embodiment of elements of design, detailing, materials or craftsmanship that renders it architecturally significant or innovative;
  - 6. Its archaeological significance to the community, county, state or nation by virtue of information yielded or is likely to yield important to history or prehistory;
  - 7. Its character as a particularly fine or unique example of utilitarian structure including, but not limited to, farmhouses, buildings or other commercial structures with a high level of integrity or architectural significance;
- 8. Its representation of a sense of time and place unique to the City.

#### **History**

The impressive three-story brick commercial building at 226 W. State St. was built in 1887 (according to St. Clair County records) by Bavarian native Michael Wachter who had moved to O'Fallon about 20 years previous. He was a cooper (maker of casks and barrels) by trade but later operated a brickyard, bakery, saloon and boarding house. He was an early member of the O'Fallon Village Board of Trustees. The building was generally called the Wachter Building or Wachter's Hall in reference to the spacious hall located on the second floor. A building next door to the east was also called the Wachter Building, so sometimes the two are confused in historical records. Collectively, they were known as Wachter's Block. The decorative iron façade was manufactured by Christopher & Simpson Architectural Iron & Foundry Co. of St. Louis, Missouri.

Over the years, the first floor of the building hosted a variety of businesses including stores selling shoes, clothes and an assortment of other goods. The O'Fallon Progress office and press occupied that floor from 1913 to 1926. The upper hall was used to host such events as plays (presented by both local talent and traveling companies), recitals, concerts, balls and dances, school presentations and entertainments, meetings, dancing classes, poultry shows and even silent movies. Until the Taylor Opera House was built at the end of 1908, the O'Fallon High School graduations were held there beginning with the first one in 1903.

In 1946 the building was converted for use as a chicken hatchery operating under various names until about 1955. After that, it was acquired by Schwarz Furniture who converted it into a three-floor furniture warehouse and display annex to complement their main store at 225 W First St. At one time, the exterior bricks had been painted with blue gray paint. Under the ownership of Schwarz Furniture, the paint was removed revealing the original brick.

Schwarz Furniture went out of business in 2010. In January 2013 world renowned photographers Salvatore and Taylor Cincotta stepped in and purchased the building, beginning a \$1 million renovation with the intent of restoring it, as much as possible, to its original glory. Completely restored inside and out, the building is now home to Cincotta Photography and their related ventures — a stunningly beautiful and functional example of what historic renovation can do for a commercial building.

#### **Architecture**


An architectural style which began with the reconstruction of Paris during the reign of Napoleon III (1851-1870) made its way across the Atlantic and became so popular during the prosperous years of Ulysses S. Grant's presidency that it became known as the "General Grant Style". Its outstanding characteristic, both in the USA and in Second Empire Paris, is the mansard roof, in which the steeply-sloped roofline of an attic storey is given windows allowing the upper floor to look like a roof while functioning as livable space.


Our example, O'Fallon's Wachter building, now the Salvatore Cincotta photography studio, is typical of commercial structures in the General Grant style. Its front facade is symmetrical, with six window openings in each of the upper two floors. The ground floor is marked by a series of cast-iron columns, derived from the Greek Doric style, but rectangular in shape, fluted, with modest decorative elements including a fan detail above the pediments at either end of the building. The columns were manufactured by the Christopher Simpson Co., of St. Louis, Mo., in a manner similar to their more famous cousins, the cast iron architectural elements made by Mesker.


The division between the first and second floors is marked by a line of dentils. A balcony with two entry doors rests above the dentil. A more extensive pediment projects out from the building to mark the division between the second and third storeys. The pediment has a short return around the sides of the building and is supported with a series of decorative brackets.


Both the East and West facades are plain, with brick-arched-top windows. Diamond-shaped steel plates reveal the presence of connecting iron rods which span the building under its floors. Chimneys rise straight up from the sides of the building.

The renovations undertaken by the Cincotta firm include opening up the ground floor windows to full store-front style; restoring the balcony; opening up all of the windows on the mansard roof; stabilizing the building's fabric to guarantee that it will survive well into the future; to say nothing of extensive interior renovations all of which are in harmony with the building's historic character.









## Ordinance #\_\_\_\_\_ Amending Chapter 111 "Peddlers and Solicitors" of the O'Fallon City Code of Ordinances.

**WHEREAS:** the City currently maintains, as part of its Code of Ordinances, Chapter 111 Peddlers and Solicitors; and

**WHEREAS:** the Ordinance does not regulate those individuals who request of or solicit from the general public, a donation for money, goods or other articles or property; and

WHEREAS: such actions may create a nuisance within the City if not regulated; and

**WHEREAS:** it is in the best interest of and for the welfare of the residents of the City of O'Fallon and the general public, that such acts be regulated.

#### **NOW THEREFORE:**

Chapter 111 Peddlers and Solicitors of the City Code of Ordinances is hereby amended by addition of the following:

#### 111.02 **Definitions**

**Panhandler.** A person who pan handles.

<u>Panhandling.</u> Any solicitation made in person upon any street, public place or park in the City in which a person requests an immediate donation of money, goods or any other form of gratuity from another person. When the person being solicited receives an item of little or no monetary value in exchange for a donation under circumstances where a reasonable person would understand that the transaction is, in substance a donation, it is a donation for the purpose of this Section.

Panhandling shall not include, except as specifically provided in this Section, passively standing or sitting with a sign or other indication that one is seeking donations, without addressing any solicitation to any specific person other than in response to an inquiry by that person.

#### 111.09 Regulations and Prohibitions.

It shall be unlawful to engage in an act of panhandling within the city limits of O'Fallon when either the panhandler or the person being solicited is located at any of the following locations; at a bus stop; in a public transportation vehicle or public transportation facility; in a sidewalk café.

Panhandling will be permitted only between one half hour after sunrise and one half hour before sunset on any day.

Each act of panhandling prohibited by this action shall constitute a public nuisance and a separate violation of this Code.

- 1. Panhandling a person who is standing at an automated teller machine while located within twenty feet (20') of that person and within one (1) minute after the person leaves the machine.
- 2. Panhandling within twenty feet (20') of the entrance to a bank and within one (1) minute after the person leaves the bank.
- 3. Repeating a panhandling request when the person solicited is stationary and has refused an immediately prior request made at that location.
- 4. At any time immediately before, during, or after the panhandling request, touching the solicited person without that person's consent.
- 5. Directing profane or abusive language at the person solicited at any time immediately before, during or after panhandling.
- 6. Immediately before, during, or after panhandling, making any statement other than the panhandling request or acting in any other manner which, in light of the circumstances taken as a whole, would cause a reasonable person to feel harassed, intimidated, or compelled to contribute.
- 7. Panhandling a person while such person is standing in line and waiting to be admitted to a commercial establishment.
- 8. Blocking the path of a person being solicited, or the entrance to any building or vehicle.
- 9. Following behind, or alongside or walking ahead of the person who walks away from the panhandler after being solicited.
- 10. Panhandling in a group of two (2) or more persons.

Panhandling will be permitted only between one half hour after sunrise and one half hour before sunset.

Each act of panhandling prohibited by this section shall constitute a public nuisance and a separate violation of this Code.

#### 111.99 **Penalty.**

Anyone who violates any provision of this Chapter for which another penalty is not specifically provided, shall be penalized as provided in Section 10.99 of the City's Code of Ordinance.

  - a. Tier  $1 1^{st}$  violation \$500
  - b. Tier  $2 2^{nd}$  violation \$1000
  - c. Tier  $3 3^{rd}$  violation Permanent revocation to solicit in the City of O'Fallon

In addition, the current Peddlers and Solicitors ordinance does not address panhandlers and panhandling. Definitions were established for panhandler, panhandling, and aggressive panhandling. It is in the best interest of and for the welfare of the residents and businesses of the City of O'Fallon, and the general public, that such acts be regulated.

**List of committees that have reviewed**: After First Reading, Gander Mountain approached the city with a revised site plan proposing a larger footprint than initially planned, expanding from their initially proposed 52,000 sq ft to 61,000 sq ft. After staff review, the site plan was determined to be satisfactory and meet city ordinances, therefore, staff would recommend the revised site plan to the Council for approval on Second Reading, as amended. The Community Development Committee reviewed this request at its October 13, 2014, meeting, and recommended it unanimously for approval.

#### **Background**

The applicant, Nick Messian for Brooks-Amaden on behalf of Gander Mountain, has requested the City consider approval of a 61,000 sq ft retail store with 250 parking spaces (244 required by city code) on the 5.64 acres of land consisting of three parcels generally located at 1234 Central Park Dr..

Please see the attached amended site plan.

Gander Mountain is also requesting Tax Increment Financing. The project is located in the Central Park TIF on a lot with a 50/50 split with the school districts and other taxing bodies. Currently, staff is negotiating with Gander Mountain on the Redevelopment Agreement, and an agreement is expected to come forward to the city council for review in the near future.






