The regular meeting was called to order at 7:00 p.m. by Mayor Graham who led the Council in "The Pledge of Allegiance to the Flag."

JoAnn Fischer came forward about her concern of spending money on the design of Ashland Avenue and whether it was practical if we are low on money. She was also concerned about the homes on Carson and Lawn. She complained about the City sending out information about St. Elizabeth Hospital in the billing, as both sides should be represented. She was also concerned about the water tower. She voiced her opposition about the sale of the water department. She commended H. Roach and J. Drolet for holding town hall meetings.

Mayor Graham stressed that Ashland is important because of the sales tax revenue from that area. We are still trying to attract companies like Costco and Trader Joe's. Green Mount and Frank Scott Parkway is already filled to capacity. St. Elizabeth Hospital will bring jobs to the area, so our children do not have to leave. The cell tower is authorized by State law; we were not able to do anything about it. He also stated that the mailing did not cost anything extra.

Vicki Thorsen also came forward to ask that the sale of the water be placed up for vote of the people. She is concerned our bills will be much higher with a company. She is also concerned about the level of service, as she is very pleased with our employees.

List of committees that have reviewed: Public Works Committee

Background: The Indian Springs Sanitary Sewer Lift Station is in the rear yard of 818 Lakeshore at the edge of Fairwood Lake. This problematic lift station is exceedingly hard to service and in recent months our crews have noticed pipe separations in the area. The lift station needs to be in an area where our crews can easily service it without trafficking through landscaped areas. The lift station will be relocated to an area near the curb of the vacant lot at 902 Indian Springs. While this is being accomplished several stormwater issues in the area will be addressed as well. As this is emergency work, staff is looking to take this on with in-house personnel assisted by an excavation contractor, this month.

Legal Considerations, if any: None, beyond normal consideration when contracting for professional services.

Budget Impact: Funds exist in the current, FY15 operating budget for the design.

Staff recommendation: Staff recommends execution of the RESOLUTION for an agreement with Thouvenot, Wade & Moerchen, Inc., in a total amount of \$8,400.

Subject: RESOLUTION – Woodstream Sewer By-Pass Design Revision Proposal

List of committees that have reviewed: Public Works Committee

Background: The City's south sanitary sewer trunk main was put in place in 1969 and with the construction of the Woodstream Subdivision was modified to snake through the housing area. Several 90-degree bends in the main cause it to surcharge manholes during times of heavy flow. With the addition of the Memorial East Hospital the trunk main section through Woodstream will be overwhelmed with the additional flow. Several options were explored to relieve this problem and a lift station with a force main to divert the high flows around the subdivision was finally selected by staff. Additionally, a segment of nearly 1,300 lineal feet downstream from the subdivision has been found to be in such poor condition that it needs replacement as well. All of this is a scope change from the original, rather simple gravity main that was envisioned in the original project.

Therefore, the original consulting fee of \$91,151 needs to be increased by \$111,859 to accommodate the change in scope and design effort as well as complete the needed study for a rail grade boring permit.

Legal Considerations, if any: None, beyond normal consideration when contracting for professional services.

Budget Impact: Funding for design of the project is available from the current FY15 operating budget.

Staff recommendation: Staff recommends execution of the RESOLUTION for an agreement with Gonzalez Companies, in a total amount of \$203,010.00. The sum of the original agreement plus the change in scope as detailed above.

List of committees that have reviewed: The Community Development Committee reviewed the agreement at its November 24, 2014 meeting and unanimously recommended it for approval.

Background

The petitioner, James Joseph, has filed a petition to enter into an annexation agreement for the property located at 10037 Rieder Road, Parcel Number 04-26.0-300-014, having approximately 6.86 acres. The parcel is currently zoned A (Agricultural District) in St. Clair County. The property will be zoned A, Agricultural District upon its annexation to the City of O'Fallon. The attached annexation agreement includes one free residential water tap that was offered due to the property owner granting the city an easement for a 12 inch water main several years ago.

Legal Considerations: None

Budget Impact: Free water tap in exchange for easement.

Staff Recommendation

Staff recommends approval of the resolution.

PRE-ANNEXATION AGREEMENT

This Pre-Annexation Agreement (Agreement) is made and entered into this 13th day of November 2014, by and among James Joseph ("Owner") and the City of O'Fallon (the "City") a municipal corporation organized and existing under and by virtue of the laws of the State of Illinois by and through its Mayor and City Council (collectively, "Corporate Authorities").

- A. Owner is the owner of record of a certain **residential** parcel of real property (Parcel ID: 04-26.0-300-014) 10037 Rieder Road, Lebanon, IL 62254, and is contiguous to or is expected to be contiguous to the City of O'Fallon in St. Clair County, Illinois, which is more particularly described in Exhibit A attached hereto and made a part hereof (the "Parcel").
- B. Pursuant to the provisions of 65 ILCS 5/11-15.1-1, et seq., a proposed Pre-Annexation Agreement in substance and form the same as this Agreement was submitted to the Corporate Authorities and a public hearing was held thereon pursuant to notice, all as provided by statute and the ordinances of the City.
- **NOW, THEREFORE**, in consideration of the premises and the mutual covenants and agreements herein contained, and in compliance with the ordinances, codes, and regulations of the City in effect as of the date hereof, or as may hereinafter be enacted, the parties hereto hereby agree as follows:
- 1 Annexation. Owners have filed with the City Clerk a Petition for Annexation of the Parcel to the City conditioned on the terms and provisions of this Agreement, which petition has been prepared, executed, and filed in accordance with 65 ILCS 5/7-1-8, and the ordinances and other requirements of the City. A copy of said Petition is attached hereto as Exhibit C and made a part hereof. To the extent that the Parcels are not yet contiguous to the City, Owners agree to execute such additional Petition in the future as may be required by the City upon the Parcel becoming contiguous to the City boundary. Subject to the requirements and conditions herein and satisfaction of the conditions of the Petition for Annexation, the City agrees to annex the Parcels by agreement pursuant to 65 ILCS 5/11-15.1-1, et seq. Owners have filed with the City Clerk a preliminary Plat of Annexation, which contains an accurate map of the Parcel, which Plat is attached hereto as Exhibit B and made a part hereof. This annexation is not for the purpose of a new residential development
- 2. Water Supply. From the effective date of this Agreement, the City shall supply fresh, potable water service (if applicable and when available) to the Parcel in quantities and pressure sufficient in all respects to serve the needs of the Parcel and the persons therein and subject to otherwise applicable usage charges, fees and regulations, provided that any change in the use of the property is subject to and in compliance with the provisions of the City's ordinances and regulations, whether prior to or after annexation the effective date of the annexation.

3. Miscellaneous

- (a) This Agreement shall be effective for a term of twenty (20) years from the date hereof, provided that the obligations to the City shall survive such termination to the extent not inconsistent with 65 ILCS 5/11-15,1-1.
- (b) Upon annexation, the parcel shall be zoned to the City zoning classification equivalent to the County zoning in place at the time of the annexation. The Owner shall retain the right to petition to rezone their property, pursuant to the laws of the City, during the term of the agreement. The city Agrees that it will not seek to rezone the Parcel to another zoning district classification without the written petition of the Owner for the duration of the agreement.
- (c) Pole barn type construction and metal sided buildings shall be allowed for any new lawful agricultural or accessory structure.
- (d) Livestock can be had and maintained on the Parcel as provided for by requirements of the Agricultural zoning district provided that the property is zoned within that district.

- (e) Burning of yard waste generated from the Parcel shall be allowed on the Parcel in accordance with the laws of the City of O'Fallon.
- (f) One free residential water tap shall be provided for the Parcel shown on Exhibit B, when available, and subjection all other applicable conditions.
- (g) The Parcel shall be subject to all laws, codes, ordinances, fees, annexation fees, taxes, usage charges, and regulations of the City, now existing or as may hereinafter be amended, enacted or enforced, and nothing herein shall be interpreted to limit the enforceability or application of such; provided that the required annexation fee of \$2250 per unit shall NOT apply to the Parcel and be required to be paid until the Parcel is rezoned at the request of the property owner or the Parcel is developed as a new subdivision.
- (h) This Agreement and the obligations of Owner hereunder shall be a covenant that shall run with the land, shall be a provision of any sale or other contract for transfer of interest in the Parcel, and may be recorded.
- (i) The undersigned persons whether signing individually, on behalf of a municipal corporation, or by an attorney-in-fact warrant themselves: (i) to be of lawful age, (ii) to be legally competent to execute this Agreement, (iii) to be fully authorized to execute this Agreement on behalf of themselves or the municipal corporation indicated below, and (iv) to have signed this Agreement on their own behalf or on behalf of such municipal corporation as their own free acts and deeds and/or the free acts and deeds of such municipal corporation after opportunity to consult with legal counsel.
- (j) The City may terminate this Agreement prior to effective date of the Annexation on written notice to the Owner if deemed by the City appropriate in the public interest, in which event the obligations of all parties pursuant to this Agreement shall thereafter cease.

Background: The City has garnered funding for the subject project from the Surface Transportation Program (STP) administered by IDOT. The project scope is for milling, grade correction and resurfacing of the roadway; replacement of broken curb sections; and replacement of non-ADA compliant sidewalk ramps. The estimated construction cost is \$730,000 of which the grant will pay for \$357,000. The remainder of needed funding will come from local MFT funding.

Legal Considerations, if any: None beyond that of providing IDOT with the appropriate support documents for construction of the project.

Budget Impact: Funding will come from the federal grant and local MFT funding.

Staff recommendation: Staff recommends execution of the RESOLUTION for support by local MFT Funds and IDOT Local Agency Agreement for Federal Participation, in an amount of \$730.000.00.

Subject: Ordinances Establishing 2014 Annual Tax Levy

List of committees that have reviewed: Finance and Administration

Background: The annual Tax Levy must be filed with the county by the last Tuesday in December. The levy is based on the pervious year's budget and a city can not levy more in the next year than it budgeted the previous year. The rate setting EAV is the base for the next years estimate as provided by the county which they project to be \$637,601,201, only \$865,000 more than last year's EAV. The county is also expecting to apply a 2.0% multiplier for O'Fallon Township and a 2.0% negative multiplier for Caseyville Township, thereby negating any change. Due to the large number of petitions filed with the Board of Review to review property assessments resulting in possible loss of assessed values, the projected EAV was reduced by \$850,000. This reduction resulted in the 2014 estimated EAV to be almost the same as last year's rate setting EAV. The levy reflects the council's guidance to keep the property tax rate as low as possible, but yet provide the needed revenue to provide the same quality of city services. We are requesting, for most funds, the same amount we requested last year with the rate remaining the same at .8498, with the exception of ambulance and IMRF. The amount requested for IMRF was increased by \$122,902 while the ambulance was decreased by \$122,866. This adjustment was required in order to get the IMRF rate in step with the current cost requirements. The Library levy request remained the same as last year's at \$962,768. The actual EAV will not be known until the County provides final numbers the end of April 2015, at which time we will have the opportunity to evaluate and adjust accordingly.

Legal Considerations, if any: None when filed on time.

Budget Impact: The tax levy is the revenue source for the Fire Department, EMS, Parks & Library and provides additional funds to the general fund and pension related accounts.

SUBJECT: Adoption of the 2012 ICC Family of Codes – 2nd Reading

Summary

We have previously presented an ordinance for the proposed 2012 ICC (International Code Council) Code adoption, which is a periodic update of the family of codes that the City uses to regulate all construction and administer the Occupancy Permit Program in the City. This ordinance was passed on first reading at the November 17th City Council Meeting.

There are three items that need to be amended in the proposed ordinance prior at second reading. Those items were discussed at the November 24th Community Development Meeting. They are as follows:

1. We have removed the automatic fire sprinkler provision of the 21012 International Residential Code, which required sprinklers in all new one-and-two family structures (Section R313.2). When this section was added to the IRC in 2009, it allowed a reduction of the fire wall between townhouses to a one-hour rated wall as opposed to the two-hour rated wall in the previous 2006 IRC. In order for us to maintain adequate fire separation between these type units in an unsprinkled structure, we must add a new section that's states that the wall between townhouse must be a 2-hour rated wall the same as 2006 IRC, unless the entire structure is protected with an automatic fire sprinkler system. See below:

Section R302.2 Townhouses is repealed in its entirety and insert:

Section R302.2 Townhouses. Each townhouse shall be considered a separate building and shall be separated by fire—resistant-rated wall assemblies meeting the requirements of Section R302.1 for exterior walls.

Exceptions:

- 1. A common I-hour-fire-resistance-wall assembly tested in accordance with ASTM-E-119 or UL 263 is permitted for townhouse protected by a residential fire sprinkler system if such walls do not contain plumbing or mechanical equipment, ducts or vents in the cavity of the common wall. The wall shall be rated for fire exposure from both sides and shall extend to and be tight against exterior walls and the underside of the roof sheathing. Electrical installations shall be installed in accordance with Chapter 34 through 43. Penetrations of electrical outlet boxes shall be in accordance with Section R302.4.
- 2. A common 2-hour-fire-resistance-wall assembly tested in accordance with ASTM-E-119 or UL 263 is required for townhouses not protected by a residential fire sprinkler system if such walls do not contain plumbing or mechanical equipment, ducts or vents in the cavity of the common wall. The wall shall be rated for fire exposure from both sides and shall extend to and be tight against exterior walls and the underside of the roof sheathing. Electrical installations shall be installed in accordance with Chapter 34 through 43. Penetrations of electrical outlet boxes shall be

in accordance with Section R302.4.

2. The City attorney has reviewed the ordinance and has made some suggested changes to the new Section R313.2 as follows:

Section R313.2 One and Two-Family Dwellings Automatic Fire Systems A builder of one and two family dwellings to be constructed for a prospective purchaser shall offer to the purchaser at the time of entering into the construction/purchase on or before the time of entering into the purchase contract, the option, at the purchasers cost, to install or equip fire sprinklers in the dwelling, residence or unit. No purchaser of such one or two family dwelling shall be denied the right to choose or decline to install a fire sprinkler system in such dwelling or residence being purchased. Written verification by the builder affirming that a fire sprinkler system was offered to the purchaser at the time of entry prior to entering into the construction/purchase contract must be included in the permit application.

3. The Illinois Department of Public Health(IDPH) is now going to require that City's that have a plumbing program officially adopt the newest version of the Illinois Plumbing Code. We have always enforced the State Plumbing Code and plan to continue to do so. We have always worked on the premise that this is the state mandated code and saw no reason to specifically adopt it. This will be a formality and will be no change from how we enforce the plumbing code. I have attached the document that we will file with the IDPH with a copy of our ordinance.

There are no other changes in the ordinance voted on in the First Reading

Al: Woodstream Sewer By-Pass Design Revision Proposal – Staff presented a change in the current contract with Gonzalez Companies. The existing trunk main in the Woodstream Subdivision does surcharge at times of high flow. Originally, the by-pass project was to utilize a gravity system. Several options were explored to relieve the current surcharging problem, and the outcome was a lift station with a force main to divert the high flows around the subdivision. Additionally, a segment of nearly 1,300 lineal feet downstream from the subdivision has been found to be in such poor condition that it needs replacement as well. All of this is a scope change from the original design effort versus the rather simple gravity main that was envisioned in the original scoping.

Therefore, the original consulting fee of \$91,151 needs to be increased by \$111,859 to accommodate the change in scope and design effort as well as complete the needed study for a rail grade boring permit. (Closed)

Motion: Committee recommends approval of the agreement with Gonzalez Companies, Inc., in the new amount of \$203,010.00.

Item 4: Stop Signs, Chesapeake Junction and Stone Briar- Staff presented a map with stop sign locations and an ordinance change. Staff received a request from a Police Officer and residents for additional signage in the subdivisions.

Motion: Committee recommended approval of the stop sign ordinance change.

Indian Springs Lift Station Replacement Design Proposal - The Indian Springs Sanitary Sewer Lift Station is in the rear yard of 818 Lakeshore at the edge of Fairwood Lake. This problematic lift station is exceedingly hard to service and in recent months our crews have noticed pipe separations in the area. The lift station needs to be in an area where our crews can easily service it without trafficking through landscaped areas. The lift station will be relocated to an area near the curb of the vacant lot at 902 Indian Springs. While this is being accomplished several stormwater issues in the area will be addressed as well. As this is emergency work, staff is looking to take this on with in-house personnel assisted by an excavation contractor, this month. (Closed)

Items Requiring Council Action:

Item A: Tax Levy: Director of Finance presented the proposed tax levy for tax year 2014. The rate setting EAV is the base for the next years estimate as provided by the county which they project to be \$637,601,201, only \$865,000 more than last year's EAV. However, the county is also expecting to apply a 2% O'Fallon Township multiplier and a 2% negative Caseyville multiplier, thereby negating any change. Due to the large number of petitions filed with the Board of Review to review property assessments resulting in possible loss of assessed values, the projected EAV was reduced by \$850,000. This reduction resulted in the 2014 estimated EAV to be almost the same as last year's rate setting EAV, or \$636,751,201. Staff recommends requesting the same dollar amounts /levy rate as requested last year with a few exceptions. The amount requested was increased for IMRF by \$122, 902 and lowered for ambulance by \$122,866. This adjustment was required in order to get the IMRF rate in step with the current expense. The library levy request remained the same as last year. Director of Finance reminded the aldermen that we are requesting the dollar amounts, not the tax levy rate. So, if the EAV is actually higher, we will get the same dollars requested, but the rate will be lower, and vice versa, if the EAV is lower, the rate will be higher in order to get the same dollar amount. Aldermen Drolet asked about the 4% Loss of Collections and the Director of Finance said that she will most likely decline that increase since the City doesn't normally have much in the way of bad debt. All agreed. Director of Finance also gave several scenarios as to what the tax levy rate would increase and how much additional a homeowner would pay if the Aldermen were interested in increasing the General Fund in order to get additional funds for street projects. There was no interest or discussion of increasing levy rate. Motion to approve the proposed 2014 Tax levy made by Drolet, second by Gerrish. All Ayes.

Other Business:

Item A: Social Media Policy: Director of Finance explained that these were discussion points and no action needed to be taken. She explained that the Personnel code already had a detailed policy regarding social media in the workplace. Alderman Drolet commented that he was more interested in a policy regarding the posting of social media on the City's official social media site and what mechanism was in place to override a posting, should it be required. After some discussion, no formal suggestions were made in formulating a policy.

Item B: Fraud Policy: Alderman Bennett suggested Director of Finance investigate the possibility of doing an IT Audit as part of our fraud policy. Director of Finance explained the internal control/fraud evaluation the auditors do annually. As Alderman Drolet pointed out, only about 6% of fraud is discovered during an audit. There was discussion of looking into an anonymous tip line to an independent 3rd party for employees to use. Director of Finance will research and report findings. A written fraud policy will also be developed for distribution to employees.

Motion to Adjourn: Gerrish, Second Drolet All Ayes. Motion carried.
