Winter Driving Safety

Driving safely in winter weather can be a challenge for even the most experienced driver. It's easy to forget after months of mild conditions that snow and ice demand careful driving and special preparation for your vehicle. But when 17 percent of all vehicle crashes occur during winter conditions it's clear that we could all use a refresher when it comes to making our way through a winter wonderland.

Ready Your Vehicle

Driving safely begins before you even get on the road. Regular tune-ups and maintenance are the starting point for safe driving year-round. In winter, pay special attention to your vehicle's battery, wipers, coolant, tires and other systems that can take a beating when the temperature drops. If you're using snow tires, have them installed before the snow begins to fall. When you know your vehicle is ready for the road, clear your car of snow, ice or dirt from the windows, forward sensors, headlights, tail lights and backup camera.

Ready Yourself


Drive slowly. It's harder to control or stop your vehicle on a slick or snow-covered road. Increase your following distance enough so that you'll have plenty of time to stop for vehicles ahead of you. Also remember that every vehicle handles differently; this is particularly true when driving on wet, icy, or snowy roads. Take the time to learn how it handles under winter weather driving conditions. Before heading out, know the weather and traffic conditions, and plan your route accordingly. Give yourself more time to get where you're going because you'll be driving more slowly in inclement weather.

Always wear your seatbelt and make sure all passengers are properly restrained. Put the phone away and keep your eyes on the road.

Use caution when approaching a snowplow.
Snowplows typically operate at 25-35 mph.

Never pass on the shoulder side of a plow.
Plows will move snow to the shoulders.

Their fields of vision are limited.

Understanding Illinois' Cannabis Law Changes 2020

Recently there have been changes in Illinois Law pertaining to the possession and use of Cannabis.

Possession of Cannabis (Illinois Resident)

- 21 Years or older
- 30 grams of cannabis flower
- No more than 500 milligrams of THC contained in cannabis infused product
- 5 grams of cannabis concentrate
- Identification may be required to prove age.

Out of State Residents

- 21 Years or older
- 2.5 grams of cannabis concentrate
- 250 milligrams of THC in cannabis infused product
- 15 grams of cannabis flower
- Illinois does not recognize medical cannabis cards from other states

Under Age 21

- No one under age 21 may possess cannabis or cannabis infused products.
- A violation is a civil violation punishable by a fine.
- A person under age 21 may have his/her license suspended for possession or use of cannabis products in a motor vehicle. **NOTE:** This applies to a passenger as well as a driver

Parents / Adults

It is unlawful for a parent or guardian to allow a person under age 21 to use cannabis products in their home, vehicles or property. This is a Class A misdemeanor with a fine between \$500-2500. If the use of cannabis results in death or great bodily harm, a violation is a class 4 felony.

Possession of Adult Use

Cannabis in a Motor Vehicle

- (a) No driver may use cannabis within the passenger area of any motor vehicle upon a highway in this State.
- (b) No driver may possess cannabis within any area of any motor vehicle upon a highway in this State except in a **sealed, odor-proof, child-resistant cannabis container.**
- (c) No passenger may possess cannabis within any passenger area of any motor vehicle upon a highway in this State except in a **sealed, odor-proof, child-resistant cannabis container.**
- (d) Any person who knowingly violates subsection (a), (b), or (c) of this Section commits a Class A misdemeanor.

Growing / Cultivation

Only those with a Medical Cannabis Card may grow and cultivate cannabis plants.

Possession of Medical Cannabis in a Motor Vehicle

- Driver may not use medical cannabis within the passenger area of a motor vehicle upon a highway in this State.
- Driver and passenger may not possess medical cannabis within any area of any motor vehicle upon a highway in this State except in a sealed, odor-proof, and child-resistant medical cannabis container.

Restrictions on Use of Cannabis Products

- In **any** public place
- In any school bus, on the grounds of any preschool, primary or secondary school
- In any motor vehicle, on a roadway in this state or a public place
- In a private residence that is used at **any time** to provide licensed day care
- In any place where smoking is prohibited
- A person who has a school bus permit or CDL while on duty
- In close physical proximity to anyone under the age of 21 who is not a registered medical cannabis patient
- A property owner/manager may restrict the use of cannabis on his/her property. This includes apartment complexes and rental homes
- A driver is still subject the provisions of driving under the influence

Put a **FREEZE** on Winter Fires

Home fires occur more in winter than in any other season. As you stay cozy and warm this winter, be fire smart!



Half of all home heating fires occur in December, January and February.



Heating equipment is involved in **1 in every 7** home fires and **1 in every 5** home fire deaths.



Keep anything that can burn **at least 3 feet** from any heat source like fireplaces, wood stoves, radiators or space heaters.



Keep portable generators **outside, away from windows, and as far away** from your home as possible.



Install and test carbon monoxide alarms **at least once a month**.



Plug only **1 heat-producing appliance** (like a space heater) into an electrical outlet at a time.



Have a qualified professional clean and inspect your chimney and vents **every year**.



Store cooled ashes in a tightly covered metal container, and keep it **outside at least 10 feet** from your home and any nearby buildings.
