DEPARTMENT FAQ

- Collinsville PD requires officers to live in St. Clair or Madison Co.



- Tattoos must not be visible when wearing a uniform, compression sleeves to cover arms are acceptable
- Starting salary \$72,281

- Fairview Heights PD requires officers to live within 25 miles of the police department
- Tattoos may not be visible on neck, face, head, or below the wrist.
- Starting salary between \$69,259 \$74,344

- O'Fallon PD requires officers to live in Illinois and within 20 miles of the police department
- Tattoos must not be visible when wearing a short-sleeve uniform, otherwise a long-sleeved uniform must be worn year-round
- Starting salary between \$75,544 \$77,204


TESTING FAQ

- The POWER fitness test consists of sit and reach, 1 minute of sit-ups, 1 rep max bench press, 1.5 mile timed run. Visit https://www.nemrt.com/Downloads/POWERTEST.pdf for specific requirements
- Valid state issued POWER tests cards, dated less than 6 months from the test date will be accepted to waive fitness testing.
- Testing will be held May 18th for those with a valid POWER test card. All others will test on May 21st.

SEVERE WEATHER WARNING SYSTEMS

The City of O'Fallon uses an Emergency Alerting System composed of nine (9) sirens strategically located throughout the City. The system is designed to alert residents and visitors of potentially severe weather, including tornado warnings and severe storms with high winds.

O'Fallon's emergency alert sirens will be activated during a **tornado warning** or when it has been confirmed that **damaging force winds with a sustained speed of 65+ mph** will impact the City of O'Fallon.

As part of a regional program, O'Fallon's sirens are tested the first Tuesday of every month at 10 a.m.



In addition to the storm sirens, the City of O'Fallon added two **lightning detection systems** in 2018 at the O'Fallon Family Sports Park and Community Park. The lightning detection systems will set off **a siren and strobe light** when lightning is in the area. When lightning is nearby, a siren will sound for 15 seconds as an initial warning and a strobe light will begin to flash. When the siren goes off, park users should move to a safe and covered area. A 20-minute countdown clock will begin once the last lightning strike is detected. With each detected lightning strike, the countdown clock restarts. After 20 minutes with no detected lightning strikes, the strobe light will stop and three, five-second siren blasts will signify the area is clear of lightning strikes.

The lightning detection system is programmed to not activate sirens or strobe lights during nighttime hours. No sirens or strobe lights will be activated typically between 10:30 p.m. and 7:45 a.m.



O'Fallon PD History

The Death of O'Fallon City Marshal B.B. Schmitt

On March 24, 1916, City Marshal Benjamin "BB" Schmitt was shot and killed. Around 5:30 PM, Marshal Schmitt made contact with two individuals, Thomas Boreman and Kenneth Ford, who arrived via the train earlier in the week. Marshal Schmitt made contact with them at the B&O train depot located in the 100 Block of East State St. in an attempt to figure out who they were and to determine why they were in town. The nature of their conversation will never be known. What is known as reported by witnesses is the conversation between Marshal Schmitt, Boreman, and Ford seemingly concluded as Marshal Schmitt turned and was starting to walk away. Witnesses claim Boreman said something to Marshal Schmitt which caused Marshal Schmitt to turn around and draw his revolver. At the same time, Boreman drew a revolver which he had. Three to four shots were fired by the two men. One of the shots fired by Boreman struck Marshal Schmitt in the heart instantly killing him. Shortly after the shooting, Marshal Schmitt was pronounced deceased by Dr. H.T Bechtold.

O'Fallon Constable McCommins who was nearby heard the shots, arrived on scene, and shot at Boreman missing him. Boreman and Ford took off running, however they were later located by resident George Monroe who held them at bay with his shotgun until help could arrive.

Marshal Schmitt's funeral was held at St. Clare Church located at the intersection of West Third & South Oak. He is buried in the O'Fallon City Cemetery. By all accounts, Marshal Schmitt was a deeply respected member of this community and City Marshal.

In April of 1916, a Grand Jury indicted Boreman on a charge of Murder and in October the case went to trial. Boreman never denied killing Marshal Schmitt and claimed it was in self-defense. A jury later acquitted Boreman on the charge of murder. Boreman later apologized for the killing and offered his \$24 a month Army pension to the family Marshal Schmitt left behind.

Marshal Schmitt's name has been added to the National Law Enforcement Officers Memorial Wall in Washington DC and in Springfield IL.

A replica depot where the shooting took place is now the home of the O'Fallon Chamber of Commerce across from Shooters.

Generator Safety

Downed utility lines, power company blackouts, heavy snow falls or summer storms can all lead to power outages. Many people turn to a portable generator for a temporary solution without knowing the risks.

- Generators should be used in well ventilated locations outside at least 5 feet (1.5 metres) away from all doors, windows, and vent openings. Measure the 5-foot (1.5 metres) distance from the generator exhaust system to the building.
- Never use a generator in an attached garage, even with the door open.
- Place generators so that exhaust fumes can't enter the home through windows, doors or other openings in the building. The exhaust must be directed away from the building.
- Make sure to install carbon monoxide (CO) alarms in your home. Follow manufacturer's instructions for correct placement and mounting height.
- Turn off generators and let them cool down before refueling. Never refuel a generator while it is hot.



Store fuel for the generator in a container that is intended for the purpose and is correctly labeled as such. Store the containers outside of living areas.

Just Remember...

When plugging in appliances, make sure they are plugged directly into the generator or a heavy duty outdoor-rated extension cord. The cords should be checked for cuts, tears and that the plug has all three prongs, especially a grounding pin.

If you must connect the generator to the house wiring to power appliances, have a qualified electrician install a properly rated transfer switch in accordance with the National Electrical Code® (NEC) and all applicable state and local electrical codes.
