The regular meeting was called to order at 7:04 p.m. by Mayor Gary Graham who led the Council in "The Pledge of Allegiance to the Flag."

Mayor's Report: Mayor Graham said that we have had 13" of snow in the last couple of days, and our crews have plowed 340 miles of streets. We have sub-zero temperatures, so the salt will not work, and we do not have any sand left. Our focus is on the snow routes, and then we go onto the side streets. However, cul-de-sacs are difficult.

He also announced that our bond rating has gone up. Only 6% of the cities in Illinois have our bond rating. That saves us millions when we do borrow over the lifetime of the loan.
